Calculation of membership fee

The membership fee for ordinary members under Article 3, Para. (1) of the VGB Statutes comprises of the basic package (calculation of fees according to the installed capacity in MW_{el} plus research and university levy) plus the fee for at least one subject-specific supplementary package.

The fee for the **basic package** depends on the installed capacity in the different categories.

A. Plants exclusively for power generation

Maximum net rated electrical output 30 €/MW_{el,net}
 (nuclear power plants, waste-, biomass-, gas-, heavy oil-, hard coal-, lignite-fired power plants)

or

Maximum net rated electrical output 18 €/MW_{el,net}
 (run-of-river-, storage-, pumped storage-, wave and tidal - , solar thermal-, geothermal-, wind-, battery- and photovoltaic plants)

B. Plants exclusively for heat or steam generation

Maximum continuous thermal output 21 €/MW_{th}

C. Plants for power and heat or steam generation (cogeneration plants)

Maximum continuous thermal output 6 €/MW_{th}

maximum net rated electrical output for maximum continuous thermal output (in accordance with plant classification A) 18 or 30 €/MW_{el,net}

The fee for the **subject-specific supplementary package** depends on the fee for the basic package.

It is obligatory to choose at least one supplementary subject-specific package.

Contribution for basic package is below or equals 5,000 €	500	[€/subject-specific package]
Contribution for basic package is above 5,000 €	2,000	[€/subject-specific package]

Supplementary subject-specific package
